which ultimately caused atrophy of shoulder musculature necessitating permanent restrictions. Injured worker performed unassisted job search for one year. Employer offered vocational assistance two months before final arbitration hearing and but could not locate suitable employment for the injured worker. Injured worker found permanently and totally disabled and awarded \$436.64 per week for life. Total expected lifetime payout \$624,395.00., , 2013 — Champaign. 08 WC 024676.

54-year-old CAN sustained bilateral shoulder injuries for which she underwent three surgeries. Permanent restrictions issued. Respondent hired two vocational experts to locate suitable light duty work and failed find suitable work over an 18-month period. Injured worker found permanently and totally disabled and awarded \$441.93 per week for life. Total expected lifetime payout \$620,469.72., , 2013 — Springfield. 07 WC 022228.

66-year-old plant maintenance worker sustained injury to lumbar spine resulting in L4-L5 and L5-S1 disk herniation. Failed two level fusion. Injured worker given permanent restrictions. Injured worker failed to locate work after job search. Injured worker found permanently and totally disabled and awarded \$538.36 per week for life. Total expected lifetime payout \$461,912.00., , 2012 — Quincy. 12 IWCC 0936. 56-year-old municipal worker sustained bilateral lumbar and S1 radiculopathy and degenerative disk disease aggravated by work injury resulting in permanent work restrictions. No surgery. Failed job search placed injured worker in ""odd-lot"" category of permanent and total disability. Injured worker awarded \$466.13 per week for life. Total expected lifetime payout \$581,730.00. Case settled after Commission award., , 2012 — Quincy. 12 IWCC0715.

52-year-old CNA sustained injury aggravating previous lumbar spine condition necessitating lumbar fusion. Permanent work restrictions issued. Petitioner's failed job search resulted in finding of permanent and total disability. Petitioner awarded \$420.33 per week for life. Total expected lifetime payout \$671,571.96. Case settled after arbitration award., , 2011 — Springfield, IL. 07WC33626.

63-year-old truck driver involved in truck accident. Multiple injuries to back and neck, four shoulder surgeries.

Permanent work restrictions. No return to truck driving. Unable to locate suitable employment after extensive job search. Vocational expert's opinion that no stable labor market exists within which worker might find suitable employment causes

finding of permanent and total disability. Total expected lifetime payout  
\$780,467.00.
